You are cordially invited to participate in the Mainstage Center for the Arts 21<sup>st</sup> Annual Blackwood Pumpkin Festival sponsored in part by Beneficial Bank, Township of Gloucester, NJ Council of the Arts, Blackwood Development West, Sign and Design, Black Horse Pike Regional Schools, Chews Florist and many more. We look forward to seeing you return as a vendor for this extremely popular fall event and encourage new vendors to join you.

**Place:** Blackwood Town Center and all streets adjoining

**Date:** Sunday, October 6

**Rain date:** Sunday, October 13

**Time:** 11:00 am to 4:00 pm

**Expected Attendance:** Over 10,000

**Size:** Spaces are 10 x 10. You must provide your own table. Electricity is NOT available. MOST spaces have the ability to accommodate tents but this is NOT guaranteed.

**Fee:** non-profit \$30.00 (must have state assigned non-profit status number)  
Profit \$80.00

**Space Allocation:** Crafters returning from 2012 will be guaranteed their previous year's space OR a request for new location up until **August 26**. After **August 26** spaces will be filled on a first come, first serve basis.

**IMPORTANT NOTE:** Although we will do what we can to put distance between similar products, we cannot guarantee location or exclusivity. This is a large and very popular event and empty spaces in the vendor map will be filled by late coming vendors

**Merchandise:**

1. All merchandise must be hand crafted or new.
2. No foodstuffs of any kind may be sold, except as a Board of Health Approved Festival Food Vendor or food product carrying Board of Health approval. This includes baked goods, lemonade, popcorn, jams, jellies etc.
3. Vendors may ONLY sell those items listed on their application.
4. **Product Restrictions: MCA does not permit the sale of poppers, sparklers, fire-crackers, any kind of firework, silly-string and ANY type of gun.**

**Set Up:** begins at 7:30. Vendors must be set up by 10:00 am. Vehicles WILL NOT be permitted to enter the festival area after 9:30, and must be out of the festival area no later than 10:00 am. Set up SHOULD NOT begin until vehicle is fully unloaded and moved to parking area.

**Break Down:** May not begin before 4:00 pm. Cars will not be permitted in the area until 4:30 pm. You must be completely broken down BEFORE you bring your car into the area.

**Clean-up:** Vendors MUST remove all trash from their space. DO NOT leave cardboard boxes, bags etc. All spaces must be clean and free of debris & garbage at the end of the festival or the vendor will not be invited back to future events.

**Vendor Parking:** Your car must be parked in the area assigned. License plate, make and model of car must be included on application form. *NO FORMS WILL BE PROCESSED WITHOUT THIS INFORMATION.*

**Payment:** Please write all checks to: Mainstage Center for the Arts and mail to: Mainstage Center for the Arts, 27 South Black Horse Pike, Blackwood, NJ 08012. Att: Anne Marie Weaver. Registrations are non-refundable. There is a \$35.00 additional fee for any returned checks.

**Confirmation:** Receipt of application will be sent via e-mail. Space assignments and festival maps will be sent with in two weeks of the event.
